The Fund is suitable for investors (on a selection / private basis only) seeking a balanced portfolio with a focus on long-term capital appreciation and income.

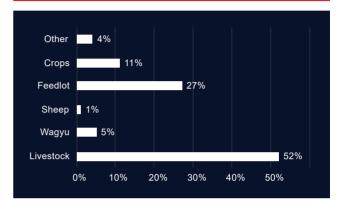

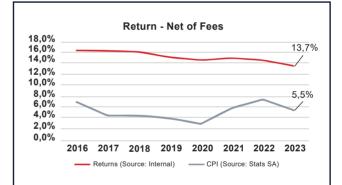
